Item No. 03: Upgrading Punalur to Ponkunnam road (SH 8) - Package 8A- Km

0+000 (Punalur) to Km 29+840 (Konni).

The Steering committee in its 108th meeting held on 04.09.2019 had decided to award the work of Punalur-Konni stretch of Punalur — Ponkunnam Road to the second lowest bidder, M/s Dineshchandra R. Agrawal Infracon Private Limited if they are willing to take up the work at the quoted rate of L1 amounting to Rs. 221.04 crores, since the work cannot be awarded to the M/s RDS Project Limited in JV with M/s Cherian Varkey Construction Co. Pvt. Ltd. as per the prevailing circumstances, where the owner of M/s RDS Project Limited in JV with M/s Cherian Varkey Construction Co. Pvt. Ltd. has been arrested for fraud and corruption.

In the meantime M/s CVCC & M/s RDS Projects Ltd. Vide G.O (Rt)No. 52/2019 dated 25.10.2019 M/s RBDCK was entrusted to initiate action against the contractor M/s RDS for the lapses as per PWD Manual. The Hon'ble High Court, vide their interim order on WP(C) No. 30487/2019 (I) dated 12.11.2019 has stayed all coercive actions against M/s RDS including attachment of the bank accounts of the petitioner, pending disposal of the writ petition.

As per the Judgment dated 04th May 2020 by the Hon'ble High Court, on the W.P.(C).No.26853/2019 filed by CVCC Company Pvt. Ltd. and & W.P.(C).No.31556/2019 (T) filed by RDS Projects Ltd. the decision of 108th Steering Committee Meeting was quashed and judgment of the Hon'ble High Court is as follows:

"In the light of the findings aforesaid, I deem it appropriate to dispose of the writ petitions quashing Ext.R5(c) decision taken by the Steering Committee of KSTP pending writ petitions to award the work covered by Ext.P1 procurement notice, and directing the State Government to complete the proceedings contemplated for blacklisting M/s RDS Project Ltd., after giving them notice indicating the grounds on which they are proposed to be blacklisted from undertaking Government works. Ordered accordingly. It is also directed that if it is found

in the said proceedings that M/s RDS Project Ltd. is liable to be blacklisted for any legitimate reason, work covered by Ext.P1 procurement notice shall be re-tendered. It is further directed that if it is found in the proceedings that M/s RDS Project Ltd. is not liable to be blacklisted, the work shall be awarded to the Joint Venture of the petitioner."

Accordingly the matter was placed in the 112<sup>th</sup> Steering Committee held on 12.06.2020 for a decision on compliance of the Hon'ble High Court Judgment, which was referred to the Government for an appropriate decision in consultation with the Law Department.

The legal opinion from Sri. K.V Manoj Kumar, Sr.Govt Pleader can be summarized as follows:

- 1. Blacklisted contractor is not entitled to continue with any of the work under the same department.
- 2. It is true that to complete the proceedings for blacklisting notice is to be issued and hearing is to be offered and therefore naturally it may take some time. The issue of delay in awarding the subject work may cause some practical difficulty in view of the fact that it is a World Bank Aided Project.
- 3. The re-tender proceedings will also cause considerable delay. In these circumstances, if the work is awarded to the RDS Projects Limited let there be a specific notification to the effect that the award of work is subject to the proceedings being taken to blacklist the contractor and all consequences of the blacklisting as referred to above, will follow.
- 4. It is to be noted that in the writ petition the Hon'ble High Court directed that the petitioner/joint venture of M/s. RDS Projects Limited is entitled to award the work only in the situation where the Government finds that M/s. RDS Project Limited is not liable to be blacklisted. (Please refer page 41 of the judgment).

As per the opinion of the Law Department, the work can be re-tendered only if the petitioner is liable to be blacklisted or else the work should be awarded to the JV of the petitioner itself. Opinion on the scope of appeal is not obtained from the AG.

The Government in response to the KSTP letter KSTP/2062/2019-AE-9 dated 06.05.2020 has mentioned that Government's stand, on Palarivattam, Public Works Department has not relaxed its stand on that issue. The beneficial verdict of single bench of the Hon'ble High Court to the contractor is challenged by the Department of Public Works with

A. Also

Department has not found any major fault with RDS on other works they are executing in the State. Hence Public Works Department has nothing to comment at present on other works. Regarding KSTP works aided by World Bank, it is the World Bank and the Steering Committee headed by Chief Secretary with Law Secretary, Finance Secretary, Public Works Department Secretary etc. that shall take decision. Hence Steering Committee may take decision of the Punalur – Ponkunnam Road of the KSTP work. Decision may be taken by Steering Committee as per facts available both on point of Law and on point.

Earlier, the Final Evaluation report was submitted to World Bank recommending rejection of M/s RDS Project Limited in JV with M/s Cherian Varkey Construction Co. Pvt. Ltd. by stating the FIR filed against the company by Vigilance and Anti-Corruption Bureau on 21st August 2019. But the World Bank vide the replied dated 27th August 2019 has informed that the Bank would not accept blacklisting/debarment based on State rules/procedures even if the case is concluded. As such the Bank returned the Final Evaluation Report to review the decision of The Evaluation Committee and to consider the offer of M/s RDS Project Limited in JV with M/s Cherian Varkey Construction Co. Pvt. Ltd. The Steering committee therefore decided to use the state share of the project for the work. The project period is ending on April 30, 2021 and project had put a request for extension by another one year which is yet to be granted. The work completion time for this package is 2 years hence urgent decision on same is required for successful completion of the project.

The Steering Committee had a detailed discussions based on the legal opinion received from the senior Govt. Pleader, Law Department, stand communicated by the Administrative Department, World Bank policy and the fact that any delay would lead to cost escalations and increase State share spending. The Steering Committee by consensus resolved to:

## Resolution No. 1:

The work of Punalur-Konni (Package 8A)-Km 0+000 (Punalur) to Km 29+840 (Konni) may be awarded to M/s RDS Project Limited in JV with M/s Cherian Varkey Construction Co. Pvt. Ltd at their quoted rate of Rs.221.04 crores (2.45% below

Extension of time for Consultancy Services for Project Management (PMC) for Kerala State Transport Project-II.

AEE-4 The positioning of the Project Management Consultant (PMC) in the Project Management Unit is one of the criteria for Project Readiness prescribed by the DEA. The World Bank had insisted that the PMC should be placed in the Project Management Team (PMT) of KSTP to augment technical and managerial skill of the PMT to provide effective support to the top management.

Thus M/s Eptisa was selected as the PMC through International Competitive Bidding. The selection procedure adopted was Quality and Cost based selection as per World Bank's

Minutes of 113<sup>th</sup> Steering Committee of Kerala State Transport Project guidelines, January 2011. An agreement was executed with M/s EptisaServicious De Ingenieria Pvt. Ltd on 14.02.2019 for a contract amount of Rs.2,83,89,000/- + GST and the services commenced on 05.03.2019. The Project duration was 15 months which came to an end as per the agreement on 04<sup>th</sup> June 2020.

The World Bank in the Aide Memoire of 13th Implementation Support Mission, March 2020 has mentioned about the need to extend the contract till the revised Project Completion date of April 2021. Considering, the balance civil works of KSTP - 2 under implementation item rate packages 3A&3B, 4A&B, EPC works for 8B& 8C, RKI Contracts and Road Safety works under Challenge Fund the PMC's active involvement for monitoring progress becomes critical.

Accordingly, M/s Eptisa has submitted a variation proposal for the extension of time of their services. The financial implications are explained in the following table.

Component C – Extension of time for the completion of consultancy services.

KSTP has engaged M/s Deloitte Touche Tohmatsu India LLP (DTTILLP) and M/s Consulting Engineers Group Limited for the subject consultancy services under Component C of KSTP-II.

The overall objective of this project: PWD management needs a support of an advisory body/ think tank for transforming the sector and undertaking reforms to put it in the track of sustainability. Some of the thematic areas identified by PWD for the COE include innovation in design/construction practices, road asset management, road safety, quality assurance and contract management and promoting indigenous R&D, dissemination through seminars and IT systems and preparation of state specific manuals/guidelines based on research. In this context, a study has been envisaged to Conceptualize and Implement COE for Road Sector in the State. The commencement of consultancy services for the subject assignment was 01/03/2019.

The Consultancy services include two phases as listed below.

Phase I: Institutional Review and COE/s Conceptualizatio Phase (6 months). Phase II: Implementation Phase (6 months).

The deliverables of Phase - I are as follows,

- Inception Report
- 2. Report on review of sector themes, current Institutional arrangements to drive each of themes and need for a COE

9. Preparation of Note and presentation to PWD/GoK including Roundtable discussions, as may be required.

The deliverables of Phase - II are as follows,

- (a) Provide advice, guidance and clarifications to PWD on any study findings/actions plan prepared by the Consultant to 1st Phase;
- (b) Provide assistance in drafting of Terms of Reference for procurement of services under the action plan for the COE/s under the different thematic areas;
- (c) In some aspects of the abovementioned Tasks, the Consultant may also be required to provide expert review and guidance to PWD for monitoring other Consultants work that may be engaged by the Client for implementation of COEs;
- (d) The monthly and-/or quarterly progress reporting undertaken by the Consultant during these services shall be submitted to the KSTP II/WD in a determined format for inclusion by the KSTP-PIU/WD in overall monitoring and reporting on implementation progress.

The consultant has submitted all deliverables (9 deliverables) included in Phase-I. Final deliverable submitted on 10/01/2020. During the World Bank mission in March 2020, discussion held on 05/03/2020 with the Consultant on the various recommendations put forward. It has been decided to house the COE in the KHRI with necessary Governance and Administrative arrangements and to create a Task Force to determine the road map to transform KHRI as CoE. The Consultant was advised to revise the Final Report and Draft note to incorporate the above changes.

Accordingly, the Consultant has submitted a revised Final report and Draft Note on 25/04/2020 and the same was sent to Government for approval on 15/05/2020. The Government has accepted the recommendations as per G.O.M(s) No.53/2020/PWD dated 11/06/2020 for Upgradation of KHRI as CoE and set-up the Task Force, CoE Management Team and CoE Administration Team.

The service of the consultant has already expired on 29/02/2020 including Phase-I and Phase-II timeline. But Implementation phase (Phase – II) has to be completed. Phase – II shall be activated in the event of affirmative decisions by PWD / GoK (as appropriate) on relevant Study recommendations and submitted Note from Phase-I on the proposed COE/s as above. Where positive/epabling decisions on (Phase I) Study recommendations have been

The PWD C-Class license holder is only eligible to take work upto 5 lakhs only. The estimated cost of this work is Rs.38,44,179/- . The Electrical and Civil works in the Trauma Care unit wards No. 7 and 8 at the Medical College, Thiruvananthapuram can be proceeded only after finalizing the AC works. Since the bidding done thrice was non-responsive and no response to the quotation also and the Electrical and Civil works are to be done in correlation with the AC works, further the loan period of World Bank will expire in April 2021, it was decided to entrust the work to the Contractor after getting additional Performance Guarantee and permission from the PWD Registration Authority (Chief Electrical Engineer). Item No. 09: Climate-Resilient Reconstruction after Flooding in Kerala-Request for Proposals for Consulting Services for Project Management.

Two loan agreements (80+90 million Euro) were signed on 30.10.19 between the Financing KfW Bank & India (as borrower) together with one 3 million Euro Financing agreement (BMZ no- 2018 704 50) for Climate-Resilient Reconstruction after flooding in Kerala. Separate agreement was also signed on 06.11.19 between the KfW Bank & the Public Works Department (PWD), Government of Kerala (GoK), the project execution agency (PEA).

The World Bank funded roads up-gradation works of similar kind were already being implemented by the Kerala State Transport Project (KSTP), a project management team (PMT) created well within the PWD. The procurement process for selection of a project management consultant (PMC) was initiated and it was decided to entrust the role of interim project management consultant (PMC) to the already existing PMC, M/s EPTISA to assist the KSTP, till the regular PMC is procured & comes on board. The interim PMC role has been fulfilled by M/s EPTISA since then and the procurement process for regular long term PMC has been completed in two stages, seeking regular consultations from KfW Bank, with financial bids opened recently in 2nd stage process.

In response to the notification for EoI published in the dailies on 11.10.2019, eleven applications were received. The evaluation committee chaired by the secretary to Government, PWD shortlisted the following six firms.

- 1. SAI Consulting Engineers Pvt. Ltd. (SYSTRA Group Company)
- 2. Louis Berger Consulting Pvt. Ltd., India JV with The Louis Berger Group, Inc., USA.

Ltd. (SYSTRA Group Company) is approved by the Authority

KSTP agreed to the KfW, proposal of E-submission and verification of receipt of bids via a third party platform (company - EXficon). This option is a response of KfW to the current COVID situation and related issues with postal services.

The Technical proposals were opened on 18.06.2020 at 16.30 Hours local time. The Technical proposals were evaluated by the Evaluation Committee consisting of Secretary, PWD, Project Director-KSTP and Chief Engineer-KSTP and the following scores are allotted.
